COMMENTS TO THIRD-CLASS MEDICAL EXEMPTION REQUEST TOP 3,000 - DRIVE FOR 5,000!



Aviators are making their voices heard in response to the EAA/AOPA third-class medical certificate exemption request, as more than 3,000 comments have been made to the FAA docket on the

proposal. More comments are needed, though, to help show the broad support for this measure. Less than two weeks remain in the FAA's 20-day public comment period for the proposal, which would give pilots who fly recreationally the option of getting a third-class medical or, instead, participating in a recurrent online education program that will teach them how to self-assess their fitness to fly. HOMEBUILT CAMPING, PARKING AREAS EXPAND AT OSHKOSH



Growing demand has brought an increased supply of homebuilt aircraft parking and camping spots for AirVenture 2012, in an area that has become more and more popular since it first opened

about a decade ago. More than 75 parking and camping spots for homebuilt aircraft owners and pilots will be added adjacent to the current homebuilt camping area, immediately north of the P-1 taxiway. This new parking area was formed by the annexation of the former Red Lot auto parking area and closure of a secondary admission gate. [Read more](#) The circular also retained FAA's option to include experimental category aircraft in an AD, but it must clearly state that inclusion. Examples may include an emergency AD involving an immediate safety of flight issue or products that may be installed on both type certificated and non-type-certificated aircraft, such as aircraft engines, propellers, and similar products. Although the release of the AC provides some clarification, EAA will continue to work with the FAA to further define and clarify AD applicability to experimental aircraft. →

PILOT'S BILL OF RIGHTS ACTION IN U.S. SENATE



Sen. James Inhofe (R-OK), a longtime EAA member and GA pilot, is continuing his efforts to bring his "Pilot's Bill of Rights" legislation to a floor vote of the full U.S. Senate. The measure, if passed, would provide pilots with expanded due process rights in case of FAA enforcement

actions, as well as clarify NOTAM and medical certification procedures for general aviation. [Read more](#) →

The public comment period for the EAA/AOPA Third-Class Medical Certificate Exemption request ends on Monday, July 2! If you haven't commented yet, do so now. Even if you have, you can add comments or submit new ones. The count is already above 10,000 – let's not stop now!

It's fast, easy, and goes directly to the FAA Docket for the exemption request.

Act now – take 10 minutes at home, in your hangar, at the EAA chapter building or airport terminal, or anywhere else and let your voice be heard. Each comment is another voice and the only way the FAA can gauge the overwhelming public support for this proposal.

Here's what some fellow EAA members are saying:

"The third-class medical has never made any sense to me. There are no data that indicate it has any impact on safety. On the other hand, there are plenty of data that indicate that educating a motivated group about healthy behavior, including self-monitoring outcomes, can be beneficial to individual health and group health indexes."

"Getting the medical or not has very little with my medical fitness for flying, since I am obligated by the FARs to self-assess before each flight."

New FAA motto: "We're not happy, until you're not happy."



Your aircraft must undergo a re-registration process sometime between January 31, 2011 and October 31, 2013. The precise date for re-registering your aircraft is determined by the month of its last registration (see table below).

The feds are running significantly behind in processing the re-registration applications. Thus, if you wait until the last month to re-register, your airplane could be grounded for several weeks or more while the federal pencil-pushers get around to completing the re-registration process. Keep in mind that there are no more temporary or "pink slip" registrations.

More importantly, if your current registration expires, your airworthiness certificate is technically no longer valid. Thus, flying without a current registration not only is a violation of federal law, you could find your insurance void as well!
